1. What Cookies Are

Cookies are small data files stored or accessed on a user's device. Similar technologies may include local storage, pixels, SDKs and session identifiers.

2. Categories

- Strictly necessary cookies for authentication, security, session management and core portal functionality.
- Preference cookies that remember language or interface settings.
- Analytics/performance cookies used to understand service performance and usage where implemented.
- Marketing cookies, if implemented, used only in accordance with applicable consent requirements.

3. Consent

Where applicable law requires consent for non-essential cookies, the Company should provide a consent mechanism allowing users to accept, reject or manage relevant categories. Strictly necessary cookies may operate without optional consent where legally permitted.

4. Third Parties

Some cookies or similar technologies may be provided by hosting, analytics, CRM, security, payment or other technology providers. Their processing may also be governed by their own privacy information.

5. Managing Cookies

Users can adjust browser settings and, where available, the Company's cookie preference controls. Blocking necessary cookies may prevent login, security checks or portal functions from working correctly.

6. Updates

The Company may update this Policy when technology, vendors or legal requirements change. The effective date identifies the current published version.
