1. No Automatic Entitlement

A bonus or credit is available only where expressly offered to an eligible Client under written campaign or account terms. The Company is not required to offer bonuses or credits and may discontinue future offers.

2. Nature of Credit

Unless expressly stated otherwise, trading credit is not client cash, is not withdrawable, cannot be transferred, and may be removed in accordance with the applicable offer terms. It must not be represented as guaranteed profit or as a substitute for the Client's own risk capital.

3. Eligibility

Eligibility may depend on jurisdiction, account type, KYC status, funding method, campaign period and compliance/risk criteria. Restricted jurisdictions and persons are excluded.

4. Trading and Withdrawal Conditions

Any volume, holding-period or other conditions must be disclosed clearly before acceptance. The Company will not apply undisclosed conditions retroactively. Withdrawal of Client-owned funds may affect associated promotional credit if that consequence was clearly stated in the offer.

5. Abuse

Bonus hedging, multi-account abuse, collusion, false identity, chargeback schemes, artificial volume or other conduct designed primarily to extract promotional value without genuine economic risk may result in cancellation of the promotional benefit and other proportionate account action.

6. Losses and Margin

Credit may affect displayed equity or margin depending on platform configuration, but its presence does not remove the risk of loss. Removal or expiry of credit can reduce margin and may contribute to position liquidation.
