US Client Policy

This policy addresses persons connected to the United States and is designed to prevent unauthorized provision or solicitation of services.

IMPORTANT This document forms part of the contractual and/or policy framework applicable to clients and users of Altara Markets Ltd. services, subject to applicable law.

1. General Restriction

Unless the Company has specifically confirmed that a service is lawfully available to a particular person and has implemented all required registrations, permissions and controls, the Company does not intend to solicit or onboard persons where doing so would require authorization in the United States that the Company does not hold.

2. US Persons and Location

The Company may treat US citizenship, residence, incorporation, tax status, physical location, beneficial ownership or other substantial US nexus as relevant to eligibility. Clients must provide accurate information and must not use VPNs, nominees or false addresses to bypass geographic controls.

3. No Circumvention

A person who is ineligible under this Policy must not open or operate an account through another person, entity, address or device for the purpose of avoiding restrictions.

4. Existing Accounts

If the Company identifies a prohibited US nexus after onboarding, it may restrict new trading, require additional evidence, arrange orderly closure of positions and return available funds through verified channels, subject to legal and compliance requirements.

5. No US Regulatory Representation

Nothing on the Company's website or in its documents should be interpreted as a representation that the Company is registered with or approved by a United States financial regulator unless expressly and accurately stated in a current official disclosure.
