1. Cross-Border Availability

The Company does not represent that its services are authorized for active solicitation in every EU/EEA Member State or the United Kingdom. Services should not be marketed or provided where doing so would require a local authorization, passport or registration that the Company does not hold.

2. Client Eligibility

The Company may restrict onboarding based on residence, nationality, physical location, entity establishment, beneficial ownership or other regulatory nexus. Clients must provide truthful information and must not circumvent restrictions using VPNs, nominees or false addresses.

3. No MiFID/FCA Representation

Unless expressly confirmed in a current official disclosure, the Company does not represent that it is authorized by the UK Financial Conduct Authority or by an EU/EEA investment-services regulator under MiFID/MiFID II frameworks.

4. Reverse Enquiry / Unsolicited Contact

5. Existing Clients
